## Your request for information

I refer to your application for informal access to information under section 8 of the GIPA Act. In your application, you requested that we provide you with access to the following information:

*"How many claims have been filed suing NSW Ambulance as the Defendant or joint Defendant, based on the alleged negligence of NSW Ambulance employees in the performance of their clinical duties, in each of the last 3 financial years i.e. FYs 2018, 2019 and 2020."*

## How access to information is provided

Access to information held by NSW Ambulance is governed by the *Government Information (Public Access) Act 2009* (GIPA Act). In accordance with the Act your request was treated as an informal request to access information under section 8 of the GIPA Act.

In dealing with your informal request I considered:

- The information you sought and whether an overriding public interest may prevent release or whether it contained someone else's personal information.
- Whether the imposition of reasonable conditions would assist the release of the information.
- The resources and time that would be required to search for and retrieve the information.
- How the information could be supplied to you and whether it could be presented in a form that would provide you with access without affecting the interests of others.

## Searches for information

Reasonable searches for the government information were conducted. A request to identify relevant information within the scope of the request was made to the NSW Ambulance Claims and Litigation team. The NSW Claims and Litigation team obtained the information from icare (Insurance for NSW) which involved icare conducting searches for the information on their database. Following this, NSW Claims and Litigation undertook an assessment of the information and consulted with icare in order to verify its accuracy. The total estimated time it took for these processes, including the drafting of this notice of decision, was in excess of seven hours.

In future, requests for claims or insurance related information relating to NSW, particularly where complying with the request requires four hours or more of processing time, should be by way of formal access application under the GIPA Act lodged with icare as holder of the information.

## Third party consultation

NSW Ambulance was required to consult with icare in relation to the information requested. No objections were raised by icare.

## Decision

Following my consideration of your request please find below information falling within the scope of your application. The information has been released as there is no overriding public interest against disclosure of this information.
